<u>Due to COVID-19, the Public is Encouraged to Use On-line Options To Watch, Listen To and Participate in the August 11, 2020 Wind Farm (WECS) Public Hearing</u>

Attached is an advanced agenda for the August 11, 2020 Public Hearing to be conducted by the Plan Commission / Zoning Board of Appeals regarding the application for a WECS Siting Permit filed by Petitioner/Applicant LINCOLN LAND WIND, LLC. The County Courthouse doors will open at approximately 5:00 p.m. in advance of the 5:30 p.m. Public Hearing. Citizens are asked to wear a mask in consideration of current conditions. Physical attendance by the public inside the Morgan County Courthouse is limited to approximately 18 to 20 individuals, not counting County officials, County staff and consultants, and the Petitioners and consultants, due to social distancing guidelines.
