## Ordinance

# ANNUAL LEVY ORDINANCE

An Ordinance levying taxes for all corporate purposes for the COUNTY OF MORGAN, ILLINOIS, for the fiscal year commencing on the 1st day of September, A.D., 2016, and ending on the 31st day of August, A.D., 2017.

BE IT ORDAINED BY THE COUNTY BOARD OF COMMISSIONERS,  
MORGAN COUNTY, ILLINOIS:

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and the same is hereby levied for such purposes as: for the fiscal year of the said COUNTY OF MORGAN, ILLINOIS, beginning on the 1st day of September A.D., 2016 and ending on the 31st day of August, A.D., 2017.

SECTION 2: The amount levied for each object and purpose is as follows:


SECTION 3: That the County Clerk of said COUNTY OF MORGAN is hereby directed to extend the aforesaid tax in the amounts above set forth for the fiscal year of the COUNTY OF MORGAN beginning September 1, 2016, and ending August 31, 2017.


SECTION 4: Partial invalidity. That if any section, subdivision, sentence or word of this ordinance is for any reason void or invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portions of the Ordinance.


SECTION 5: Truth in Taxation Compliance. The Commissioners of the County of Morgan hereby affirm compliance with the Truth in Taxation Act and have provided public notice and conducted public hearings as delineated in the act subject to such threshold as established by the act.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage, approval and recording, according to law.
